- ◆ Coverage gap discount program begins
  - Timely PDE reporting essential
- ◆ Additional RADV audits
  - Methodology will posted for public comment
- ◆ Part D – Income Related Monthly Adjustment Amount (D-IRMAA)
  - NPRM proposes disenrollment of non-payers
- ◆ Audit process continues, using risk-based selection
  - Clear expectations and sufficient timeframes

- ◆ Bid negotiations

    - ▶ Communicate specific bid requirements
    - ▶ Provide SAS data files for OOPC - meaningful differences, total beneficiary cost (TBC)
  - Bid review schedule will be compressed
    - ▶ AEP begins Oct 15, 2011

- ◆ Reduction in LTC wasteful dispensing
